Since Volume 35, Number 1, the front cover of *Parergon* has featured medieval or early modern objects held in New Zealand and Australian collections.

Master of Uttenheim, born Tyrol, Austria/Northern Italy, fifteenth century, *St Martin of Tours and St Nicholas of Bari*, c. 1475, Pustertal, Tyrol. Tempera, gold on wood panel, 76.3 x 68.0 cm. Elder Bequest Fund 1943, Art Gallery of South Australia, Adelaide.

This panel painting depicts two saints associated with compassion and charity. On the left, St Martin, wearing fashionable fifteenth-century dress, divides his cloak with a sword to give half to a beggar. According to the popular *Golden Legend*, Jesus later appeared to St Martin in a dream, wearing the same piece of cloak. On the right of the painting is St Nicholas in the vestments of a bishop. He holds his attribute of three golden balls, representing the golden dowries he gave to three poor girls to save them from prostitution.

This painting arrived in Port Adelaide in 1881, apparently concealed under a false bottom in a wooden packing crate. In 1889 the newspaper publisher E. H. Derrington presented the painting to the Port Adelaide Museum and Art Gallery, where it was displayed until 1943, when it was purchased by the Art Gallery of South Australia with funds from the Elder Bequest.

In 1950 the panel was identified by Dr Julia Wilde of the Courtauld Gallery as the work of the Master of Uttenheim, named for an altarpiece originally in the Marienkirche of Uttenheim in the Tyrol region of Austria. The central panel of that altarpiece, which depicts the Virgin and Child with Saints Margaret and Barbara, is now in the Belvedere in Vienna, and it is likely that the panel now in Adelaide originally formed part of one of its wings.

Authors should observe the conventions of the Modern Humanities Research Association, as outlined in the *MHRA Style Guide* (3rd edn, 2013). Essays should be substantially original, advance research in the field, and have the potential to make a significant contribution to the critical debate. *Parergon* does not accept submissions that have already been published elsewhere. Kim Walker Postgraduate Travel Bursary

The bursary is awarded to the person who most nearly fits the following criteria:

- · A postgraduate currently enrolled at a university in New Zealand or Australia
- A New Zealand postgraduate when the conference takes place in Australia or an Australian postgraduate when the conference takes place in New Zealand
- · A postgraduate who is in particular need
- A postgraduate who is giving a conference paper that is specifically related to the conference theme and/or on the subject of early modern women's writing.

Due to the ongoing COVID-19 pandemic, the 2022 ANZAMEMS conference was held solely online, and so the Association did not award the Kim Walker Bursary in 2021.

Parergon Prize

The *Parergon* Prize is awarded to an emerging scholar for the best article-length scholarly work accepted to be published in *Parergon* within the previous three years.

Constant Mews Early Career Publication Prize

The Constant Mews Early Career Publication Prize honours the work of Professor Constant Mews, FAHA, a former President of ANZAMEMS, and distinguished scholar in the medieval history of religions, intellectual history, and textual editing and translation. The Prize rewards outstanding work by Early Career Researchers in Constant's broad areas of scholarly interest.

ANZAMEMS Early Career Fellowship Program

The ANZAMEMS Early Career Fellowship supports the development of early career researchers in pursuing advanced research and publication in medieval studies, early modern studies, and medievalism.

Fellowships are awarded on the basis of the project's merit, and the expected contribution the fellowship funding and mentorship will make to the project advancing towards publication and dissemination.

ANZAMEMS-ARC Humanities Award for Original Research

The ANZAMEMS–ARC Humanities Award for Original Research is aimed at Early Career Researchers, including those completing their first books, and independent scholars. The winner of the Prize benefits from ARC Humanities expert advice on converting a PhD thesis to a monograph.

The 2021 ANZAMEMS–ARC Humanities Award for Original Research was awarded to Dr Anna Dorofeeva (Free University of Berlin) for *Reading Nature in the Middle Ages: Writing, Language and Creation in the Latin 'Physiologus', ca. 700–1000.*

The 2022 ANZAMEMS–ARC Humanities Award for Original Research was awarded to Dr Georgina Pitt (The University of Western Australia) for *Ælfred mec heht gewyrcan: The Persuasive Agency of Objects and Social Practices in Alfred the Great's Reform Programme.*
